The North Point Sail Racing Association, its Sail Race Committee, its Officers, Directors, members, employees and agents and any one or more of them, does not by holding the race represent, assure, or vouch that entries are seaworthy, well-found or in compliance with applicable safety regulations, or that the captains or their crew have any experience. Participation in any North Point Sail Racing Association Races is at the captain and crew's sole risk.
